- **A copy of the vehicle registration document (Registration certificate)** for vehicles registered in the Republic of Slovenia obtains the data from the vehicle register of Republic of Slovenia or the issuance of a new registration plates with a different registration number DARS ex officio directly by inspecting the register of registered vehicles in Republic of Slovenia. For vehicles, which were registered or unregistered abroad, the person required to pay the toll must present a document issued by the official body in that country. **Document composed in a foreign language must also be submitted with translated document into Slovenian by a sworn translator.**

The person liable to pay the toll, must submit the application within 30 days from the deregistration of the vehicle from the register of registered vehicles or from the day when a new registration plate with another mark was issued with registration mark to which the electronic vignette is attached, request a refund of the residual value electronic vignettes.

**I understand that the unjustified obtaining of (a relative proportion) the value of a electronic vignette on the basis of false information is a criminal offence.**
